THE AMAZING HUNT PAYMENT AND CANCELLATION POLICY

[UPDATED ON JULY 9, 2026]

- a. The Amazing Hunt accepts payment by direct deposit, cheque payable to Bill Lin, or credit card via PayPal. A PayPal invoice or payment link will be provided upon request. PayPal payments are subject to a 3% processing fee for Canadian dollar transactions and a 5% processing fee for payments made in other currencies. All quoted prices and payments are in Canadian dollars.
- b. The Amazing Hunt will require a non-refundable deposit based on your selected event. If the total cost of your event is \$5,000 CAD or more and/or your event requires services provided by third-party vendors or businesses, including but not limited to reserving private venues or spaces or purchasing products or services from vendors or businesses, a non-refundable deposit equal to 50% of the total event cost, plus any quoted or applicable third-party vendor costs, will be required and must be received at least 3 weeks prior to your preferred event date.
- c. The outstanding balance must be received no later than 12 hours before the scheduled Group Booking. If payment is not received by this deadline, The Amazing Hunt reserves the right to suspend or cancel the event without liability. Any deposits or payments already received remain subject to the applicable refund policy.
- d. The Amazing Hunt reserves the right to adjust the invoice to reflect any additional attendees or any last-minute fee increases imposed by vendors or businesses. The Amazing Hunt also reserves the right, at its sole discretion, to revise the cost-per-person rate or withdraw any discounts if there are changes to the number of attendees on the event date. No changes to the number of attendees will be permitted within 48 hours prior to your scheduled group event. However, if there are any last-minute additions to your group, your organizer and/or representative must notify The Amazing Hunt at least 24 hours prior to the start of the event.

Any dispute regarding the organizer's authority, the authorization of a payment method, or any matter between the organizer, the group or organization, the cardholder, the financial institution, or any third party shall be resolved solely among those parties and shall not affect the organizer's obligations under this Agreement or require The Amazing Hunt to refund any payment or waive any fees otherwise payable under this Agreement, except as required by applicable law.

These photos may be posted on the Program's Instagram account. If your group consents to this practice, your organizer and representative must sign in the designated area below to indicate such consent. If your group chooses not to consent, please leave the designated area blank, and our staff will not take any photos or videos during your event.

All attendees hereby release the Program and all individuals associated with it from any and all claims, actions, damages, liabilities, losses, costs, and expenses of every kind and nature, including, without limitation, legal fees, arising out of, resulting from, or relating to their participation in the Program.

Intending to be legally bound, all attendees, on behalf of themselves and their respective heirs, executors, administrators, and legal representatives, hereby waive, release, and forever discharge any and all rights, claims, causes of action, damages, and liabilities that they now have or may hereafter have against all individuals, organizations, and legal entities affiliated with The Amazing Hunt, including, but not limited to, the Producer and the production crew of The Amazing Hunt, both individually and collectively, arising out of or relating to their participation in, travel to, or return from the Program.
