



## THE AMAZING HUNT NON-DISCLOSURE AGREEMENT AND RELEASE AND WAIVER [UPDATED ON JULY 1, 2025]

As an inducement to The Amazing Hunt (the "Producer") to consider me as a potential participant in its programs (collectively referred to as the "Program"), and by agreeing to and acknowledging The Amazing Hunt Non-Disclosure Agreement and Release and Waiver (collectively referred to as the "Application"), I represent, warrant, and agree as follows:

1. I understand that the Program refers to any past, present, or future iteration, regardless of its official name or branding changes, and includes any events, competitions, or productions created, organized, or hosted by The Amazing Hunt. This definition shall remain valid and enforceable in all circumstances.
2. I understand and acknowledge that, although the Producer reviews all Applications, including all submitted materials such as photographs, video submissions, and written materials (collectively referred to as the "Materials"), the Producer will be unable to reply to all applicants individually. I understand that I will only hear from the Producer if I am selected as a participant.
3. I understand, represent, and warrant that I meet and will comply with the eligibility requirements to be considered as a participant in the Program, which are as follows: (i) I am over the age of 19 as of the date of the Program. If I am under 19 years old, I must attend the Program with my legal guardian on the day of the Program, limited to "Battle Royale" and "City Expedition"; (ii) I must be available and able to commit to all days of filming as notified by the Producer. The dates are subject to final determination by the Producer at its sole discretion; (iii) I must be in good physical and mental health. I must disclose any phobias and/or allergies that may affect my health and well-being. I am also sufficiently self-aware to stop any activities before I become ill or injured; (iv) I agree to cooperate with the Producer during my participation in the Program and to interact appropriately with the other participants.
4. I acknowledge that: (i) I have read, understood, am satisfied with, and agree to be bound by the eligibility requirements set forth in this Application; (ii) I have answered the questions in this application honestly, accurately, and completely; (iii) I agree to keep all information about the Program, which I acquire during the participant selection process, strictly confidential; (iv) Even if I am selected as a participant, the Producer has no obligation to produce the Program or to exhibit it, even if produced; (v) All decisions made by the Producer regarding the selection of participants are final and not subject to challenge or appeal; (vi) The Producer has the right to change any terms of the application or the participant selection process at any time and to select or not select participants at its sole discretion. I warrant and represent that I have full rights and authority to grant the rights in the Materials to the Producer as contemplated herein.



5. I hereby release the Producer, along with any involved organizations, businesses, and personnel, from any and all claims, actions, damages, liabilities, losses, costs, and expenses of any kind (including, without limitation, legal fees) arising out of, resulting from, or in connection with my participation in the Program. This includes, without limitation, my involvement in the participant selection process, participation in any Program-related activities, any exploitation of the Program or my appearance on it, the Producer's decision not to select me as a participant, the cancellation of the Program, any activities related to the video submission, or the exercise by the Producer of any rights granted by me with respect to the Program. These claims are released on any legal basis whatsoever, including but not limited to personal injury, rights of privacy and publicity, false light, and defamation (the "Released Claims"). The Released Claims specifically include, without limitation, any and all claims, actions, damages, liabilities, losses, costs, and expenses (including legal fees) of any kind resulting from the actions of another participant or any third party at any time.
6. With respect to the information I provide in this application, including, but not limited to, all "personal information" collected by the Producer and/or its authorized agents pursuant to the terms herein, I acknowledge and agree that any such information obtained by the Producer through this application or by other means may be used for the purpose of making casting and other similar decisions for the production (and public viewing) of the Program. This information may also be described, disclosed, or otherwise used in connection with the Program (by the Producer), any subsequent seasons of the Program, and any ancillary or related productions, including "making-of," "behind-the-scenes," or "after-show" productions, and for related publicity and promotional purposes.
7. I acknowledge and agree that the Producer reserves the right to change the terms and conditions of this Application at any time without notice. I also agree that the Producer reserves the right to ask me to sign any additional releases deemed necessary in relation to the Program if I am selected as a participant. Additionally, all decisions regarding the Program, including, but not limited to, rules, eligibility, participant selection, production, gameplay, tasks, and elimination, are at the Producer's sole and exclusive discretion, are final, and are not subject to appeal. The Producer reserves the right to disqualify any participant for tampering, threatening, or harming another person; violating the official rules or any other rules in effect at the time; or breaching the standards, practices, and policies of the Producer. Furthermore, the Producer reserves the right to change any rules related to the Program at any time.
8. When I am selected as a participant in the Program, I shall maintain the strictest confidentiality regarding any information or materials of any kind, including, but not limited to, information or materials related to the Producer, any Program produced by the Producer, the Program participants, the Program hosts, or the events featured in the Program. This includes any information or materials I may read, hear, acquire, or learn in connection with my application to participate in the Program or, if selected, as a result of my experiences as a participant (collectively referred to as the "Information and Materials"). I acknowledge and agree that the Information and Materials are confidential and the exclusive property of the Producer. At no time will I, directly or indirectly, divulge, use, or permit others to use any of the Information and Materials.



9. When I am selected as a participant in the Program, I must follow and subscribe to the Program's social media accounts, including, but not limited to, Instagram, starting from the day my participation in the Program begins. Additionally, I am required to repost and share at least four Instagram posts and/or stories featuring myself from the Program's Instagram account on my own Instagram account within one week of the original posting.
10. The Program is not considered a competition but rather a produced, reality TV style project. If monetary compensation is provided, it will be classified as a stipend and may be issued to me based on the following criteria, including, but not limited to: (i) completing the project on the filming day; (ii) ensuring the entire project is published on the Program's social media; (iii) fulfilling my reposting and sharing obligations regarding the Program's Instagram posts and/or stories; and (iv) being available for other upcoming Program(s) if selected to participate. The stipend will only be provided via e-transfer to a Canadian bank account. The Producer reserves the right to modify the stipend amount at any time and does not accept negotiations.
11. I hereby consent to the production, reproduction, broadcast, publication, exhibition, distribution, adaptation, recording, use, and reuse by the Producer, in any and all media now known or hereafter devised, in connection with The Amazing Hunt and the potential reality-based television series (collectively referred to as the "Releasees"), of my voice, language, actions, manner, likeness, name, appearance, biographical material, still pictures, videos, and any information (collectively referred to as the "Likeness") obtained or derived from my application process and my participation in the Program. Such Likeness may be edited, altered, or modified by the Releasees in any manner, in any and all media now known or hereafter devised, in connection with the Producer and all related productions, including publicity materials, spin-offs, or advertising. The scope of related productions will be limited to the Program, personal portfolios, and demonstrations of skill sets by the Producer and the production crew of The Amazing Hunt. I agree that the Releasees may use all or any part of my Likeness and may alter or modify it, regardless of whether or not I am recognizable. I further irrevocably grant and fully assign to the Releasees the exclusive ownership of any and all rights, titles, and interests (including, without limitation, all copyrights) in and to the Materials, any other videos, recordings, still pictures, and any other materials that I have provided or may provide in connection with the participant selection process and my participation in the Program. Additionally, I release the Producer from any and all liability arising from its recording or use of my Likeness and/or the Materials, including, but not limited to, any claims of invasion of privacy or publicity rights.
12. Intending to be legally bound, I hereby, for myself and my heirs, executors, administrators, and any affiliated associations, waive, release, and forever discharge any and all rights or claims for damages and contractual violations that I may have now or in the future against any persons, organizations, or legal entities affiliated with The Amazing Hunt, and particularly the Producer and the production crew of The Amazing Hunt, individually and collectively. This includes any and all damages or contractual violations sustained or suffered by me in connection with my entry into, participation in, or travel to and returning from the Program.
